Purpose and Aims

- The purpose of the FAQ Level 3 Certificate in Emergency Response Ambulance Driving (RQF) is to provide Learners with the skills, knowledge and understanding required to prepare, drive and manoeuvre ambulance vehicles under both routine and emergency response conditions.
- This qualification is designed for road systems subject to UK legislation and covers driving legislation, driver responsibilities, pre-driving checks and daily inspections, the system of car control, driving under routine and emergency response conditions, manoeuvring and reversing, safety systems, emergency response driving practices, navigation, adverse conditions and human factors.
- This qualification meets the requirements for ambulance service drivers to claim exemptions under road traffic legislation and to operate to the specification of the Road Traffic Regulations Act (exemption for speed limit regulations).
- This qualification is aimed at individuals who work, or intend to work, as an ambulance support worker, associate ambulance practitioner or an HCPC registered paramedic.

This qualification forms part of the FutureQuals Ambulance Service Driving Qualification Suite.

To achieve the FAQ Level 3 Certificate in Emergency Response Ambulance Driving (RQF), Learners must meet the rules of combination and follow any guidance relating to pathways, barred Components and Component order.

Pathways - Learners must choose one of the three pathways, based on the vehicle that all learning and assessment will take place in.

Learners may be assessed in either a manual or automatic vehicle, regardless of the pathway chosen. The vehicle make and model the Learner is assessed in should match the vehicle type used in operational service. However, if an employee is required to drive a vehicle of a different transmission type to that in which they were assessed, it is the responsibility of the trust/employer to conduct familiarisation training.

Rules of Combination - Learners must achieve the two mandatory Components from *Group M – Mandatory Components* of their chosen pathway.

Learner Requirements and Information

Entry Requirements

Learners must:

- be 18 years of age (or older) on the first day of teaching.
- possess the right values, behaviours and attributes appropriate to the role.
- not have any outstanding court cases, prosecutions or pending disciplinary action in any area being brought against them.
- have a contract with either an NHS ambulance service or a voluntary or private ambulance provider that is CQC registered and contracted to provide emergency ambulance provision to the NHS ambulance services. For devolved nations, this will be the CQC equivalent ambulance service, if applicable.
- hold a full, valid driving license for the class of vehicle being driven for the full duration of the qualification.

In cases where Learners hold a non-UK-issued full driving licence, Centres are responsible for undertaking their own due diligence to ensure that the Learner meets all requirements of current UK legislation.

The Centre is responsible for ensuring that no Learner is accepted on the programme where it is evident the validity period of their full driving licence and/or the validity of the class of vehicle will not expand the full duration of their qualification. Should a Learner's driving licence expire, for whatever reason, the Learner must be placed on a break until such time their driving licence permits them to continue. The qualification must still, however, be completed within the qualification registration period or the Learner withdrawn until such time they can meet the required standards.

There are no formal qualification entry requirements that Learners must complete prior to completing the qualification. Learners will, however, need to have minimum core skills in literacy, numeracy and ICT to successfully complete the qualification. Initial assessment of minimum core skills may be carried out for all Learners commencing the qualification.

Please note, throughout the delivery of this qualification, Learners may also be referred to as 'Trainees'.

Ongoing Requirements

Throughout the qualification, Learners must always act in a professional manner, in accordance with agreed ways of working. Negative attitudes, values and behaviours will not be tolerated and could lead to suspension or withdrawal of registration. Learners must also notify their Tutor/Assessor immediately of any disciplinary actions, outstanding court cases or prosecutions. The Centre must then notify FutureQuals with immediate effect.

Throughout the qualification, Learners must have a contract with either an NHS ambulance service or a voluntary or private ambulance provider that is CQC registered and contracted to provide emergency ambulance provision to the NHS ambulance services. For devolved nations, this will be the CQC equivalent ambulance service, if applicable.

Reasonable Adjustments and Special Considerations

Identification Requirements

It is a Centre's responsibility to confirm the identity of a Learner as part of its registration process, and for any online assessments.

The following are acceptable examples of proof of a Learner's identity:

- a valid passport (any nationality)
- a national identity card issued by an EU country
- a Gibraltar identity card
- a signed UK photocard driving licence
- a valid warrant card issued by HM Forces or the Police
- other photographic ID card, e.g., employee ID card (must be current employer), student ID card or a travel card

Learner Authenticity

It is a regulatory requirement that assessment evidence is authenticated as the work of the named Learner. Therefore, FutureQuals require that a declaration of authenticity is signed by the Learner for each assessment submitted (this includes e-portfolio systems). If an assessment is conducted online via the XAMS platform, Learners will also be asked to declare that the assessment attempt is their own.

If a Centre uses their own pre-approved version of a FutureQuals evidence log, the same information must be captured as in the FutureQuals-issued evidence log, i.e., the assessment method, evidence reference, the Assessor's decision (including the signature and date to evidence completion of assessment) and the Learner's declaration of authenticity. The Learner must sign and date the declaration.

Crossover Routes for Additional Pathways

Successful completion of this qualification only authorises the Learner to drive at high speeds in the class of vehicle in which the qualification was delivered and assessed.

For Learners wishing to qualify on an additional pathway post-achievement of this qualification, they must be registered on, and achieve, the new pathway separately.

Recognition of Prior Learning (RPL)

RPL is a method of assessing and validating learning, achievement or credit that considers whether a Learner can demonstrate they meet the assessment requirements for a Component. This may be through knowledge, understanding or skills they already possess.

Provided the assessment requirements of a given Component or qualification have been met, the use of RPL is acceptable for the achievement of a Component(s) or a whole qualification. For further information, Centres should refer to the *FutureQuals Recognition of Prior Learning Policy* which can be found on the FutureQuals website.

Requalification

Once awarded, the FAQ Level 3 Certificate in Emergency Response Ambulance Driving (RQF) certificate does not expire. However, it is a CPD requirement of the qualification that Learners must complete refresher training in line with government guidance, in order to continue in a role involving emergency response ambulance vehicle driving. Attainment and evidencing of CPD is the responsibility of the Learner and their employer. Evidence of CPD does not need to be provided to FutureQuals, unless requested.

Centre Requirements and Information

Qualification Delivery Requirements

Resources: Centres must have in place vehicles of appropriate performance and capability for all pathways they are approved to deliver. Vehicles used in the delivery of speed training courses must also meet the requirements as set out in the most current version of the Road Traffic Regulations. All Component-specific vehicle requirements must also be met.

Learner Ratios: The ratio of Learners to Assessors during all driving practical elements must not exceed 3:1, with one Learner driving the vehicle and the other two Learners observing.

Guided Learning Hours in Blocks/Modules: Where training is provided in blocks/modules, these should be no less than 15 hours in total over two days.

Teaching Hours: The teaching requirements for this qualification are based on a 37.5-hour teaching week. However, days may be extended to accommodate the requirements of driving during the hours of darkness. The minimum course length should be no less than three calendar weeks.

Assessment: Assessment must be carried out as outlined in the Qualification Assessment section of this specification.

Workforce Requirements

In order to deliver, assess and quality assure the FAQ Level 3 Certificate in Emergency Response Ambulance Driving (RQF), Centres must first have applied for, and received, approval to offer the qualification. All Centres must also gain separate approval for each of the pathways they wish to deliver. Please note, approval for Pathway 3 will be by exception.

Centres must have in place appropriately experienced and qualified staff. This includes Tutors, Assessors, Invigilators and Internal Quality Assurers (IQAs). All workforce requirements can be found in *Appendix 2 - FutureQuals Emergency Response Ambulance Driving Assessment Principles*.

The Ambulance Driving Principles: Traffic Signs, Signals and Markings assessment, the Theory Test Before Commencing On-road Training at Speed assessment and the Pre-Emergency Response Driving Competence Assessment must all be completed and passed before proceeding to the high-speed driving learning outcomes of this Component.

Appendix 1 – FutureQuals Emergency Response Ambulance Driving Assessment Principles

v4.0 March 2023

The FutureQuals Emergency Response Ambulance Driving Assessment Principles are designed to ensure a consistent approach to the elements of assessment requiring further interpretation or definition.

The assessment principles apply to the Components that assess occupational knowledge and occupational competence in the following qualifications:

- FAQ Level 3 Certificate in Emergency Response Ambulance Driving (RQF)
- Certificate in Emergency Response Ambulance Driving at SQCF Level 6
- 1. These assessment principles must be applied in addition to the generic criteria and regulations outlined in the *FutureQuals Assessment Principles*.
- 2. To ensure there is appropriate support for, and monitoring of, Learners during practical sessions, Components 2, 3 and 4 must be delivered in line with the requirements set out in the relevant Component.
- 3. The assessment methods required for both knowledge-based and competency-based criteria are listed in Components 1, 2, 3 and 4. Where assessments have been externally set by FutureQuals, these must be used. Where evidence collection tools have been provided by FutureQuals, these must be used unless prior permission to use an alternative evidence collection tool has been granted.
- 4. All formal assessment, both internally and externally set, of Learner performance contributing to the achievement of this qualification must comply with the conditions set out in the *FutureQuals Instructions for Conducting Controlled Assessments*.
- 5. It is a requirement for the Learner to be aware that assessment is taking place.
- 6. Competency-based assessment must take place in a real-life working environment. The use of simulation is only permitted when undertaking reversing manoeuvres or demonstrating emergency response ambulance vehicle positions (in-line, fend-in and fend-off), where exact facilities cannot be utilised safely.
- 7. All assessments for Components 2, 3 and 4 must be carried out in the vehicle type specified in the chosen pathway.
- 8. Assessment decisions must be made by a currently, and occupationally, competent FAQ Level 4 Diploma in Emergency Response Ambulance Driving Instruction (RQF) L4DERADI® qualified Staff Assessor (defined below).

- 9. Expert witnesses are not permitted for this qualification.
- 10. The details of the requirements of Tutors and Assessors are set out separately. It is accepted, though, that both roles may be performed by the same person, providing the qualifications and experience requirements for both roles are met. However, the Final Independent Driving Assessment must be conducted by an Independent Assessor (Final Examiner).
- 11. FutureQuals maintains a register of all approved Tutors, Assessors, IQAs and other key workforce personnel involved in the delivery of our qualifications. We reserve the right to suspend or remove Tutors, Assessors, IQAs or other approved workforce personnel from our Approved Workforce Register should their status change or information be brought to our attention that confirms they no longer meet the conditions below. This means they may be temporarily or permanently unable to be involved in the delivery or quality assurance of this, and other FutureQuals qualifications.

However, the FAQ L4DERADI® qualification must be completed within the designated registration period and, during this time, Trainee Tutors must be undertaking supervised or consolidation practice and be mentored by a qualified FAQ L4DERADI® Staff Tutor (from the Centre the Trainee Tutor is registered with for their FAQ L4DERADI® qualification).
- 6. Trainee Tutors do not, however, meet the requirements for pathway 3. To deliver pathway 3, Tutors must hold the FAQ L4DERADI® qualification, meet all other requirements listed above, and have relevant evidence of their experience teaching in a class 2 ambulance response car. This evidence must be accompanied by a letter of support from a FutureQuals National Principal Assessor (NPA).

Assessor Requirements

- 1. All assessments must be carried out, unless otherwise specified, by a currently occupationally competent Assessor who is qualified to make assessment decisions.
- 2. Assessors must be currently occupationally competent and hold the FAQ L4DERADI®.

However, the qualification must be completed within the designated registration period, and during this time, Trainee Assessors will need to be mentored, and have all their assessment decisions countersigned by a fully qualified, currently occupationally competent FAQ L4DERADI® Staff Tutor/Assessor (from the Centre the Trainee Assessor is registered with for their FAQ L4DERADI® qualification).

Trainee Assessors cannot perform the role of Independent Assessor, unless there is an FAQ L4DERADI® Staff Tutor/Assessor present in the vehicle during the Final Independent Driving Assessment who signs to confirm their presence and countersigns the assessment decision. The FAQ L4DERADI® Staff Tutor/Assessor must also meet the Independent Assessor (Final Examiner) requirements for both the Learner and the Trainee Assessor.

Invigilator Requirements

- 1. Externally set, marked and quality-assured assessments must be invigilated by a suitably competent Invigilator.
- 2. Assessments taken under controlled assessment conditions must be invigilated by a suitably competent Invigilator.
- 3. Invigilators must appear on their Centre's skills matrix and have received standardisation training prior to any invigilation duties.
- 4. Invigilators must adhere to all requirements set out in the *FutureQuals Instructions for Conducting Controlled Assessments*.

Internal Quality Assurer (IQA) Requirements

- 1. Internal Quality Assurers (IQAs) must be currently occupationally competent and hold the FAQ L4DERADI®.
- 2. IQAs must hold either the Level 4 Award in the Internal Quality Assurance of Assessment Processes and Practice, or the Level 4 Certificate in Leading the Internal Quality Assurance of Assessment Processes and Practice, depending on the role of the individual. IQAs holding the V1 or D34 legacy qualifications are not required to requalify.

- 3. IQAs must not have any outstanding court cases, prosecutions or pending disciplinary action in any area being brought against them.
- 4. Trainee IQAs registered for, and actively working towards, a recognised internal quality assurance qualification can also meet the minimum IQA requirements, providing all other IQA requirements are met. However, internal quality assurance qualifications must be achieved within one year of registration and, during this time, trainee IQAs will need to have all their verification decisions countersigned by a currently occupationally competent FAQ L4DERADI® fully qualified IQA (as outlined above), approved by FutureQuals.

External Quality Assurer (EQA) Requirements

- 1. External Quality Assurers (EQAs) must be currently occupationally competent and hold the FAQ L4DERADI®.
- 2. EQAs must hold either the Level 4 Award in the External Quality Assurance of Assessment Processes and Practice, or the Level 4 Certificate in Leading the External Quality Assurance of Assessment Processes and Practice, depending on the role of the individual. EQAs holding the V2 or D35 legacy qualifications are not required to requalify.
- 3. EQAs must not have any outstanding court cases, prosecutions or pending disciplinary action in any area being brought against them.
- 4. Trainee EQAs registered for, and actively working towards, a recognised external quality assurance qualification can also meet the minimum EQA requirements, providing all other EQA requirements are met. However, external quality assurance qualifications must be achieved within one year of registration and, during this time, trainee EQAs will need to have all their verification decisions countersigned by a currently occupationally competent FAQ L4DERADI® fully qualified EQA (as outlined above), approved by FutureQuals.
